- (18) The school shall abide by the provisions of the Tamil Nadu Recognised Private Schools (Regulation) Act 1973 and Tamil Nadu Recognised Private Schools (Regulation) Rules 1974.
- (19) The certificates of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage/time.
- (20) The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
- (21) The Management shall apply for renewal of recognition three months before the expiry of this order.
- (22) The management shall follow the directions issued by the Government/Department from time to time keeping in view of the safety and security of the children and the overall administration of the School.
- (23) The recognition shall be withdrawn if any contravention of the provisions of the Act, Rules or the conditions of recognition are found and proved.
- (24) This order may be used only for the purpose of seeking affiliation to CBSE as requested by the management and the management is not entitled to seek affiliation to any other Board.
