





5. BENEFICIARIES:

- ii. MR.S.K.VEL shall be the First Managing Trustee/Chairman of the Trust.
- iii. The vacancy created by resignation or removal of the Trustees, may be filled with the unanimous choice of remaining Trustees.
- iv. The Trustees can appoint any one of his legal heir as his successor. If any Trustee died intestate any one of his legal heir, as selected among themselves, shall hold office as Trustee.
- v. The Trustees for the time being may co-opt any one person with outstanding qualities with references to the Trust objects, whose tenure of office shall be as decided at the time of appointment.
- vi. There shall be a Chairman for the Board of Trustees, who shall preside over all the meetings of the Trust. The Managing Trustee shall be a Chairman for the Board of Trustees.
- vii. Any Trustees acted against the interest of the Trust may be expelled by the Founder of the Trust or by the unanimous consent of at least two thirds of total Trustees but not less than seven Trustees.

9. POWER OF THE TRUSTEES:

a. The Trustees shall have all powers necessary or incidental for effectively carrying out the objects of the Trust.

- b. Subject to the general provisions of the Trust and without prejudice to the general and specified powers conferred upon the Trustees by the other provisions contained in these presents, the Trustees shall have the following powers also:

 - vi. To expend the funds of the Trust in such manner as they shall consider most beneficial for the purpose of the Trust.
 - vii. To acquire, build upon, pull down, rebuild and to alter, repair, improve, sell or dispose of any land, building or premises for the use of the Trust and to acquire any movable property required for the use of the Trust and to dispose of the same.
 - viii. To acquire any property in exchange for some other property or partly in such exchange and partly for other considerations.

- xiii. To appoint and dismiss Managers, Secretaries, Clerks, Administrative Officer, Directors and other staff and workers required for working of its business or industry and for general management of the affairs of the Trust.

10. PROCEEDINGS OF THE TRUSTEES:

- i. - ii. In the absence of the Chairman at any meeting, the Trustees who may be present the meeting may nominate a Chairman for the meeting as prescribed by the rules.
- iii. The proceedings of the Trust Meetings shall be kept recorded in a Minute Book. The Managing Trustee shall have the custody of all deeds and documents of title relating to Trust properties and investments and books of accounts and other records relating to the Trust and shall be responsible for the same.
- iv. In case of difference of opinion arising among the Trustees and the votes are equally divided, the Chairman shall have casting vote, which shall be final and binding on the other Trustees.

11. BANKING ACCOUNT:

All income, subscription and pecuniary donations for the general purposes of the Trust and the income, investments and all other moneys from time to time forming part of the general revenue of the Trust shall on the same being received be paid into a banking account with any scheduled bank for the purpose of the Trust. The Bank Account shall be opened and operated as decided by the Board of Trustees from time to time.

12. ACCOUNTS AND AUDIT:

- i. The Trustee shall keep proper books of account of all assets, liabilities and income & expenditure of the Trust and shall prepare an Income & Expenditure Account and Balance Sheet for every year as on the last day of March.
- ii. The accounts of every year shall be audited by a Chartered Accountant or a firm of Chartered Accountants who shall be appointed for that purpose by the Trustees and the audited accounts shall be placed at a meeting of the Trustees, which shall be held before the end of the succeeding year.

13. DURATION OF THE TRUST:

The creation of the Trust is irrevocable and its duration perpetual and permanent, subject to other residuary clauses of this deed.

14. WINDING UP:

In the event of dissolution or winding up of the Trust the assets remaining as on the date of dissolution shall under no circumstances be distributed amongst the trustees but the same shall be transferred to some other similar Trust whose objects are similar to those of this Trust.

15. AMENDMENTS:

Subject to the Provisions of this Deed, the Board is hereby authorised to and they may from time to time, make and prescribe rules and bye laws for carrying out the objects of the Trust and for the administration of the affairs of the Trust and from time to time modify add, alter or amend such rules, regulations and bye laws.

Notwithstanding anything contained in this deed, no amendments to the memorandum and rules and regulations of the Trust shall be made which may prove to be repugnant to the provisions of section 2(15) 11 to and 80-G of the Income Tax Act, 1961.

17. HOLDING OVER OF MONIES FOR TRUST:

The Trustees may accept grants, gifts, donations, contributions, aids, bequests, legacies or any remittance in cash or in kind and they shall hold the same for the Trust. When cash or cheques are received they shall become part and parcel, of the Trust Fund.

18. ADHRENCE TO THE INDIAN INCOME TAX ACT, 1961 :

This Trust shall function in adherence to the provisions of the Indian Income Tax Act, 1961 as amended from time to time up-to-date.

19. GENERAL:

- No act or proceedings of the Board or Chairman and/or Secretary or of any Trustee shall be deemed to be invalid by reason only of any defect in the appointment or the constitution of the Board or any member thereon.
- ii. Notwithstanding the power vested with the Trustees under the precedings clauses, the Income and funds of the Trust will be solely utilized towards the objects of the Trust and no portion of it will be utilized for the payment to Trustees by way of profit, interest, dividend etc.

iii. This will be purely a Charitable Organization on the object of mitigating human sufferings run on a "No Profit" "No loss" basis principle.
